

Dan Golden, the keynote speaker, will address the conference on the topic: "Structure and Fragmentation in the Lives of Students." Dan says that he is struck by the strange combination of structure and fragmentation in student experience and how isolated classroom education is from the life and learning agendas of so many students.

Dan is the founding Director of the Filene Center for Work and Learning at Wheaton College. The Filene Center is Wheaton's life planning and experiential learning locus and oversees an institutional portfolio based reflective learning process that yields up a "Second Transcript" for all students, the Wheaton Work and Public Service Record.

Dan Golden has been a consultant and program reviewer for schools and colleges on reflective learning design and serves as an assessor for the U.S. Department of Education on innovative education and service-learning projects. He holds a B.A. from Queen's College and an M.A, Ph.D. from Indiana University/Bloomington.

Report on the NACAC 1996 Legislative Conference, Washington MARCH 2-5, 1996

During the first week of March three members of the Overseas ACAC attended the 13th Annual NACAC Legislative Conference held in Washington DC. Beth Linguri attended as the OACAC President; Peter Hauet as the President-Elect, and Cy Boschert as the OACAC Government Relations Chairperson. The time was most opportune as Washington was embroiled in tough and decisive budget negotiations involving significant cuts relative to education. The purpose of the Conference was to have NACAC be advocates of expenditures for education, specifically for students and the counseling profession.

It was an extremely well organized and professionally run exercise directed lobbying members of the United States Congress. They were an intense, interesting and exciting five days. Approximately eighty high school counselors and college admissions officers took part, with interviews arranged with over two hundred Senators and State Representatives on Capitol Hill. Beth met with Senators John Kerry and Edward Kennedy and Representatives Edward Markey and Martin Meehan, all of Massachusetts. Peter met with Senators Carl Levin and Spence Abraham, and Representative Peter Hoekstra of Michigan, and joined with Beth in meeting with Representative Markey. Cy met with Senators John Ashcroft and Christopher Bond and Representative James Talent of Missouri, as well as William Goodling of Pennsylvania.

The first three days of the Conference were devoted to briefings on the overview of the political climate in Washington and NACAC's legislative priorities, techniques and procedures to be followed in the interviews, reviewing supporting documents of the points to be raised, and biographical information, voting records and political viewpoints of the Congressmen to be visited. Discussions with two Democrat and two Republican members

of the House of Representatives to understand their parties' stand on the educational issues in question rounded out the preparation.

The four Priorities established for which we sought the support of the Congressmen were:

- A) To restore Student Aid Appropriations for the full 1996/97 academic year to enable realistic planning by institutions and by the students and families depending on assistance.
- B) To maintain funding for higher education at least at the levels of fiscal year 1995, and not implement the 200 cuts being proposed. A related issue was to maintain funding to legal immigrants who presently make up about 10% of all students receiving aid.
- C) To reject the provision which would cut funding for career and guidance counseling, jeopardizing as many as 40,000 counseling positions.
- D) Finally, to retain Affirmative Action policies in college admissions which could be eliminated if pending legislation were adopted.

In wrap-up sessions after the visits there was generally satisfaction and optimism even though many of the visits were with members of Congress who were in favor of drastic action, including considerable cuts in expenditures, in order to balance the budget and reduce the national debt. Similar visits last year seemed to have been instrumental in saving financial aid programs which were in danger of being reduced. It remains to be seen what effects this year's efforts will have on the priorities mentioned above.
